Jill Holmes, Purchasing Agent stated the service has been with Galaxy Communications which has now been bought out by Zulu Internet, Inc. and is a 5-year agreement; the current agreement permits the vendor to attach their wireless antenna to the tower and in return the County receives free service within the County as well as the electricity being paid for including air conditioning for the equipment; it is recommended the agreement be signed, to include the amendment pertaining to the name change.

ITEM 8. CONSIDERATION AND ACTION TO APPROVE FUNDING AND REPAIR OF ROOF AT SOUTH JAIL LOCATED AT 725 CR4200, BONHAM, TX - PURCHASING AGENT

Jill Holmes, Purchasing Agent stated Chief Deputy Woods advised a leak was discovered at the southwest corner of the roof; the roofing consultant came out with Heffner Roofing; Heffner stated the repair would cost up to \$1,200; in April of 2011 a white fleece-backed roofing system was recommended at a cost of \$156,000 that includes a 20 year warranty; the current roof had a 10 year warranty and it was installed 13 years ago; it is recommended the immediate repair be undertaken for a cost up to \$1,200 with a follow up inspection and a new roof be considered in the next budget cycle.

Commissioner Barker asked if the funds would come from Repair and Maintenance on the South Jail Building Repair and Maintenance Fund; Ms. Holmes answered in the affirmative, funds are available in that line item.
