- Call to Order / Establish Quorum; Commissioner A.J. Self, Chair, called the meeting to order at 9:08 a.m. Quorum established.
- Introductions: Commissioner Self Introduced Laura Robinson from the County Clerks Office.
- 3. Public Forum; No one spoke in public forum.
- Approve Meeting Minutes from 11/17/2021;
   Motion: Approve the 11/17/2021 minutes, Jim Simpson, 2<sup>nd</sup> Jarret Tucker. Motion passed 4-0.
- Discussion consideration and action regarding: Jim Allen Subdivision Regulations from TX Agri Life class in Hopkins County - Commissioner Self

Discussion from Jim Allison's recommendations:

- 1. Could impact fees be added to a subdivision for road improvement per the recommendation of an engineer?
- 2. No flag pole lots with less than 100ft road frontage.
- 3. Parcels less than 10 acres can be plated; committee still feels that the less than 5acre rule is still best for Fannin County.
- 4. No mention of road adoption should be made with the final plat.
- 5. Preliminary plats may not be necessary, only checklist, followed by a final plat application procedure.
- 6. Phased plats, master plat should be filed and then each phase as a final plat.
- 7. Family member plat exception: degree of consanguinity can be 4 generations instead of 3.
- 8. Engineer company to review plats. Engineering company that inspects in Anna could be a possibility.
- 9. Two points of ingress egress for 1000+ homes.
- Discussion, consideration and action regarding enforcement letter protocol -AJ Self
  Commissioner Self reported that he is still researching this.
