- 2. Introductions; No introductions
- Public Forum; No one spoke in public forum.
- Approve Meeting Minutes from 10/27/2021;
   Motion: Approve the 10/27/2021 minutes, Cody Jones, 2<sup>nd</sup> Commissioner Lackey. Motion passed 5-0.
- 5. Discussion consideration and action regarding: Drainage studies and drainage plans-Cody Jones. Discussion on Drainage studies included options of considering fire regulations, and reviews by fire Marshal, also of having a waiver passed by Commissioners Court rather than just one commissioner. Motion: Establish a requirement for a waiver of a drainage study to be approved through Commissioners Court. Cody Jones, 2<sup>nd</sup> Jim Simpson, Passed 5-0
- 6. Discussion, consideration and action regarding ingress & egress of subdivisions Cody Jones
  Discussion on points of Ingress & Egress, included how many lots would it be necessary to insist on multiple

  submittal.

Di Hopkins presented a section of the regulations to be reviewed. Discussion included reviewing this section for the next subdivision meeting.

9. Discussion, consideration and action regarding new Subdivision related topics in the County;
Discussion: ½ acre minimum sized lots for Fannin County, Commissioner Lackey commented that
Grayson County Commissioners Court have passed a ½ acre lot minimum requirements, it was mentioned that this was currently under review by TCEQ, Grayson County believe it will be passed, could this be a

good move for Fannin County? Jim Simpson commented that he thought this would not be a good move for Fannin County at this time, Cody Jones agreed, Dean Lackey then said he thought it was not the time to move forward with this for Fannin County.

Discussion: Duplex septic requirement in the unincorporated parts of Fannin county, the regulations require 1 acre minimum per septic system, septic's cannot be on another person's property, therefore a duplex could have a shared system if they were owned by the same person, even if rented to separate individuals, but they could not share a system if each side was owned by different individuals.
